Task:

This task is in two parts:

- 1. Media File You are required to compile a media file summarising three cases heard in either a NSW court or a Federal court in the last 12 months; and
- 2. Extended Response Write a 1,000 word (maximum) response to the question "Assess the effectiveness of the law reform process in leading to a more just society"

Your response must be typed in either 12pt Times New Roman or 12pt Arial, spaced at 1.25 lines, and with a 3cm margin on the right hand side and submitted electronically either through Google Classroom or via email to michael.p.armstrong@det.nsw.edu.au

You are expected to comply with all relevant academic referencing requirements.

NOTE: This is a *compulsory* assessment task. A 10% penalty applies for each day the task is submitted late without explanation. Part A (15 marks)

Using your independent research skills, compile a media file summarising three (3) cases heard in either a NSW court or a Federal court in the last 12 months, using printed or online news media as the primary source of information.

- Each case is to come from a different court in the NSW or Federal court system
- You must provide a dated/sourced copy of each news article cited in your file
- You must include at least one civil and one criminal case

(word limit: 750 words)

Part B (25 marks)

Write an extended response of no more than 1,000 words to answer the following question:

"Assess the effectiveness of the law reform process in leading to a more just society"

In you response you should focus upon one specific law reform issue which should be selected from the following **or** by negotiation with your teacher.

Suggested Law Reform Topics

- Young drivers and the law
- Animal welfare
- Drug use at Music Concerts
- Refugees and Asylum Seekers
- Free Speech

In answering the question you should identify one (1) specific issue with respect to your chosen topic; explain the significance of the issue you have chosen to address; and make a judgement on the effectiveness of the law in responding to this issue.
